This plan financially safeguards the Insureds if they are involved in a traffic accident in connection with the use of the insured vehicle in case they are iniured or die.

身故或完全永久性傷殘 Death or Total Permanent Disability

因駕駛或乘坐受保車輛而發生交通意外,導致被保人身故或完全永久性傷殘。

Death of the Insured or the Insured suffered from Total Permanent Disability due to a traffic accident involving the Insured being a driver or passenger in the insured vehicle

- ●保險金額為所有被保人賠償總和的最大賠償金額。
 - The benefit amount shall be the maximum compensation amount in respect to all the Insureds in aggregation.

The compensation amount to be paid shall be the maximum benefit amount divided by the number of seats of the insured vehicle or divided by the number of Insured involved in the accident.



在醫院治療的醫療費用

Medical Expenses in Hospital

因駕駛或乘坐受保車輛而發生交通意外遭受身體受傷,而需在醫院接受由醫生建議的 治療、外科及牙科治療的合理及醫療上必要的實際費用。

The actual, reasonable and medically necessary expenses incurred in a Hospital for medical, surgical and dental treatment due to a traffic accident involving the Insured being a driver or passenger in the insured vehicle.

最高保險金額為每個保單年度所有被保人賠償總和的最高賠償金額,並受限於每個 保單年度每位被保人的最高保險金額MOP5,000。

The maximum benefit amount is in respect to all Insureds in aggregation per policy year, subject to the sub-limit of MOP5,000 per Insured per policy year.



殮葬費用

Funeral Expenses

將賠償給予可提供有關文件證明支出殮葬費用的人士。

The funeral expenses shall be reimbursed to the person who can prove having incurred such expenses, against the receipt of documentary evidence.
