Both the US and Europe have experienced fluctuating downward trends in inflation. Expectations for interest rate cuts in the US for 2024 have been revised in terms of magnitude and timing. It is anticipated that interest rates will remain high for an extended period. There are additional uncertainties associated with U.S. Presidential election. A conservative approach is expected to yield stable returns.



估值的回升促進了 2024 年第二季度的表現。中國在疫情後的經濟成長受到未達預期的影響,主要原因是房地產市場的顯著下滑導致了總需求的疲軟。目前中國正面臨通縮壓力,市場情緒反映出對總需求疲軟的預期。儘管潛在的利率和銀行準備金率降低,以及政府刺激措施可能在一定程度上抵消這些風險,但這些措施的效果和時機仍不確定。與歷史水平相比,中國內地股票估值目前偏低,商業情緒也受到限制,但估值收縮可能會為資產配置帶來機遇。



Fund Commentary

The recovery in valuation contributed to performance in Q2 2024. China's post-COVID economic outlook has been marked by unmet growth expectations, primarily driven by the significant downturn in the property market, which has led to weakness in aggregate demand. The country is currently grappling with deflationary pressures, which are reflected in market sentiment that anticipates continued weakness in demand. While potential interest rate and bank reserve rate reductions, as well as government stimulus measures, may partially offset these risks, their effectiveness and timing remain uncertain. While Mainland stock valuations are currently low compared to historical norms, and business sentiment is also limited, valuation contraction may present opportunities for asset deployment.

基金評論

Fund Commentary


Emerging Equity Market have exhibited signs of strengthening performance in Q2 2024 when measured in local currency terms. Companies generally reported earnings growth and improved valuations. Notwithstanding the positive outlook, uncertainties persist surrounding the trajectory of inflation, commodity price volatility, and fluctuations in energy costs. Furthermore, fluctuations in currency exchange rates may potentially influence both the U.S. dollar-denominated value of investments in emerging markets, as well as the growth prospects for export-oriented sectors.
